The Constitutional Council

- Seen the Constitution of the Kingdom of Cambodia;

- Seen the letter N° 192/0814/S/D.P of August 25, 2014 of H.E. **Say Chhum**, Acting President of the Senate, requesting the Constitutional Council to examine the constitutionality on the Amendment of Article 15 of the Rules of Procedure of the 3rd legislature of the Senate of the Kingdom of Cambodia, adopted by the Senate on August 25, 2014 in the 5th session of its 3rd legislature of the Senate, letter received by the Secretariat General of the Constitutional Council on August 25, 2014 at 14:00;

Having heard the rapporteur,

Having deliberated in compliance with the law,

- Whereas the Senate has duly implemented the procedure stipulated in Article 114 (New-one) and Article 82 of the Rules of Procedure of the Senate put into practice by the decision N° 017/0812/S/D.S of August 20, 2012 for reviewing and adopting the request to amend Article 15 of the Rules of Procedure of the 3rd legislature of the Senate of the Kingdom of Cambodia;
- Whereas the request of H.E. Say Chhum, Acting President of the Senate, made in accordance with Article 140 (New) of the Constitution and Article 16 (New) of the Law on the Amendment of the Law on the Organization and the Functioning of the Constitutional Council, is therefore admissible;

- Whereas the form in drafting and adopting the Amendment of Article 15 of the Rules of Procedure of the 3rd legislature of the Senate of the Kingdom of Cambodia has nothing contrary to the Constitution;
- Whereas the essence of Article 15 (New) of the Rules of Procedure of the 3rd legislature of the Senate of the Kingdom of Cambodia has nothing contrary to the Constitution;

Decides:

Article 1: The Amendment of Article 15 of the Rules of Procedure of the 3rd legislature of the Senate of the Kingdom of Cambodia, adopted by the Senate on August 25, 2014 in the 5th session of its 3rd legislature of the Senate, is declared in conformity with the Constitution.

Article 2: This decision made in the Plenary Session of the Constitutional Council in Phnom Penh on September 02, 2014, shall be final, without recourse, shall have authority over all the instituted powers as stipulated in the Constitution, and shall be published in the Royal Gazette.
