The Constitutional Council

- Seen the Constitution of the Kingdom of Cambodia;
- Seen Preah Reach Kram N° NS/RKM/1297/06 of December 26,1997 on the Elections of the Members of the National Assembly;
- Seen Preah Reach Kram N° CS/RKM/0498/06 of April 08, 1998 on the Organization and the Functioning of the Constitutional Council;
- Seen Preah Reach Kram N° NS/RKM/0301/04 of March 19, 2001 on the Elections of Khum / Sangkat Council;
- Seen Preah Reach Kram N° NS/RKM/0902/017 of September 17, 2002 on the Amendment of the Law on the Elections of the Members of the National Assembly;
- Seen Preah Reach Kram N° NS/RKM/0606/020 of June 27, 2006 on the Amendment of the Law on the Elections of Khum / Sangkat Council;
- Seen Preah Reach Kram N° NS/RKM/0606/019 of June 27, 2006 on the Amendment of the Article 13 (N) of the Law on the Amendment of the Law on the Elections of the Members of the National Assembly;
- Seen the letter of attorney dated November 16, 2006 of H.E. KONG KAM, Acting President of the SAM RAINSY Party, giving the power to Mr. PIM SAMNANG, member of the election committee of the SAM RAINSY Party, to be his representative in lodging the complaint and attending the hearing of the Constitutional Council;
- Seen the complaint dated November 17, 2006 from Mr. PIM SAMNANG demanding to strike the names of Vietnamese people off the electoral lists, and to reject the decision of the Hearing council of the National Election Committee signed by H.E. IM SUOSDEY on November 13, 2006, complaint received by the Secretariat General of the Constitutional Council on November 17, 2006 at 15:49;
- Seen the decision of the National Election Committee of November 13, 2006 rejectingMr. PIM SAMNANG 's complaint No 0010/06 ក.ទ.ដ.ប dated November 10 2006;
- Seen the letter N° 518/06 N.E.C. of November 23, 2006 appointing NEC representatives to attend the public Hearing of the Constitutional Council;
- Seen the minutes of investigation of the Constitutional Council's representatives in BABOANG commune, PEAM ROR commune, NEAK LOEUNG commune, PREK KSAY (A) commune, PREK KSAY (B)

- commune (PEAM ROR district), KAMPONG LEAV commune (KAMPONG LEAV district), and KAMPONG PRASAT commune (PEAM CHOR district);
- Seen the minutes of affirmation of NEC representatives on November 22, 2006 at 10h00;

Having heard the rapporteur, Having heard the parties, Having deliberated in compliance with the law,

- Whereas the complaint of Mr. PIM SAMNANG was made within the period of public posting of the initial electoral lists. In accordance with the Article 42 (N) of the Amendment of the Law on the Elections of Khum / Sangkat Council, the Article 64 (N) of the Amendment of the Law on the Elections of the Members of the National Assembly, and the Article 26 of the Law on the Organization and the Functioning of the Constitutional Council, therefore it is admissible;
- Whereas during the hearing and in his complaint, Mr. PIM SAMNANG demands to strike the names of 1,264 foreigners off the initial electoral lists in seven communes of PREY VENG province, by asserting that these people do not possess Khmer citizenship, speak unclear Khmer, do not know how to write in Khmer, live on the boats along the rivers, or rent houses and practice Vietnamese customs. He also declared that they are not qualified to get Khmer citizenship in accordance with the Law on the Naturalization, and that they do not have the rights to register for the election, should the Law on the Elections of Khum / Sangkat Council be implemented. He also wonders why some of them hold Khmer identity cards, while they do not obtain the royal Decrees granting the citizenship. He adds that the National Election Committee has held the Hearing in absence of the defendants;
 - Whereas during the hearing and in the inquiry, H.E. EM SOPHAT and H.E SOM CHANDYNA, representatives of the National Election Committee, asserted that during the Hearing at the National Election Committee, Mr. PIM SAMNANG could only affirm that these persons have Vietnamese names and surnames by picking up the names from the electoral lists, and did not specify the names of the polling station of the people whose names were demanded to be struck off. The case in BABOANG commune (PEAM ROR district, PREY VENG province), the commune council decided to strike the names of 46 among the 172 people off the lists, but those names remain the subject of the complaint lodged with the National Election Committee. H.E. EM SOPHAT reiterates that the National Election Committee respects the laws and the procedures, to delete the names entails sound and clear evidences. The fact that the National Election Committee did not make any investigation on the site owes to the existence of its structure at the communal and provincial levels. Nevertheless at the Hearing of the National Election Committee the representatives of the communes were also present along with the decision of the commune councils;
- Whereas despite the absence of the defendant, the National Election Committee can decide in absentia;

- Whereas the people whose names were demanded to be deleted from the initial electoral lists, have their names in the final electoral lists in accordance with the Article 54N point "C" of the Law on the Amendment of the Law on the Elections of the Members of the National Assembly;
- Whereas the investigation of the representatives of the Constitutional Council found out that in BABOANG commune (PEAM ROR district, PREY VENG province), 46 people had their names struck off the initial electoral lists by the commune council due to their death and change of residence; therefore, their names shall be struck off the initial electoral lists (Those names are available in the annex of this decision);
- Whereas the affirmation of the authenticity of an individual's identity is not within the competence of the Constitutional Council;

Decides: In the presence of the parties

Article 1: The complaint dated November 17, 2006 of Mr. PIM SAMNANG is admissible for its legal form but is rejected for being groundless.

Article 2: The decision of November 13, 2006 of the National Election

Committee rejecting the complaint N° 0010/06ក.ទ.ដ.ប of

November
10, 2006 is upheld.

Article 3: This decision pronounced in public hearing in Phnom Penh on November 25, 2006 shall be final without recourse, shall have authority over all the instituted powers as stipulated in the Constitution and shall be published in the "Journal Officiel".
